- Interested Parties may submit their highest price for the vehicle in a sealed cover (Cover No.1) latest by **03.00 p.m on 10.10.2025** and will be opened on the same day at **03:30 pm**. Bidders have to submit Earnest Money Deposit (EMD) amount of ₹ **5000/-** (₹ Five Thousand only) in favour of Indian Ports Association in a separate cover (Cover No.2). Cover No. 1 and Cover No.2 shall be put in on outer cover and may be sent to the Reception of the Indian Ports Association Office addressing to Head Officer (Procurement & Projects), New Delhi. The outer cover should be superscripted in bold Capital letters **"QUOTATIONS FOR AUCTION OF OLD VEHICLE OF IPA"**.
- The auction of vehicle shall be strictly on **"AS IS WHERE IS BASIS"** and no guarantee or certificate of its worthiness or quality will be given by Indian Ports Association (IPA). The condition of the vehicle can be inspected physically from 20.09.2025 to 09.10.2025 between 10.00 a.m. to 5.00 p.m at **'Rest House, Indian Ports Association, 19, Institutional Area, Lodhi Road, New Delhi-110003.'**
- If the highest tenderer/successful tenderer accepted by the competent authority in this Department fails to deposit the sale price within the prescribed time limit i.e. within 7

working days from the date of intimation to the tenderer(s) declared as highest bidder by the competent authority then the EMD of that bidder shall be forfeited.

4. Quotations submitted without EMD will be rejected.
5. The delivery of the sold vehicle will be arranged only after the successful bidder submits documentary evidence in support of residential status (Ration Card/ Voters Identity Card in case of individual and Registration Certification in case of firms etc.) The sold vehicle will be removed by the successful bidder(s) within two days from the date of intimation to the tenderer(s) declared as highest bidder by the competent authority. No assistance/transportation will be provided by the IPA. Permission to take out the disposed vehicle from premises will not be allowed on holidays, Saturdays and Sundays etc.
6. The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his name at his own cost expeditiously and submit the copy of the transferred RC. It will be the sole responsibility of the buyer for getting the necessary paper works done in accordance with the law and as per the provisions of the Motor Vehicles Act (amended from time to time) applicable for Transport Authority of Govt. of NCT of Delhi. This office will not be responsible for any lapse on the part of the buyer in this regard.
7. Indian Ports Association reserves the right to reject all or any tender in whole or part without assigning any reasons thereof.
8. The bidder is required to reveal his full name/name of the authorized signatory of the firm/name of father, full postal address, telephone number & mobile number.
9. Disputes, if any, shall be subject to jurisdiction in the Court of Delhi only.
10. If the highest quoting firm fails to honor the bid; the contract will be cancelled & next highest bidder shall be offered. In such an event, an opportunity shall be given to the next highest quoting eligible tenderer (H-2 quoting party) to complete the bid provided it is prepared to accept the prices offered by the H - I party. In case of any dispute, decision of the IPA shall be final.
11. Tender offer form should be signed in ink by the authorized signatory only. Photocopy or unsigned quotations or quotations not signed by authorized signatory shall be rejected. Tendering firm shall alone be responsible for furnishing any false or wrong information and the consequences or loss thereof.
12. GST as applicable shall be payable by the successful firm. However, please note that the quote shall be excluding GST and GST payment if applicable shall be paid before the vehicle is delivered.
13. Quotation should be offered in prescribed form only as given above.
