Period of validity of bid:

The bid shall remain valid for 90 days from the last date of submission of bids. If any bidder withdraws his tender before the said period shall -without prejudice to any other right or remedy, be at liberty to forfeit the Bid Security absolutely.

Submission of Bids / Opening of Bids:

a) The first envelope shall be super scribed with the name of work and the words "**Technical Bid**" in capital letters. The first envelope shall be opened on the date of opening of tender. The bidder should specifically provide full technical details, compliance or non-compliance for all parameter for each items in the Bid. No price details shall be given in this envelope. Violation to this would result invalidation of tender. The **Bid Security** shall be enclosed with the envelope marked "**Technical Bid**".

b) Technical Bids must contain the EMD for specified amount, along with complete technical details as desired by this tender. First, Technical Bids of all the tender will be opened on pre scheduled date, time & venue. Technical Bids without EMD will be summarily rejected. Requirement of EMD is exempted from those bidders like State/Central PSUs; Government of India Societies (established under relevant Act) and those registered with NSIC, DGS&D.

c) All the bids must be accompanied by a bid security (EMD) of the amount of Rs.5,000/- (Rupees Five Thousand Only) in a form of a Bank draft/ Banker's Cheque only issued by any commercial Bank in favor of Indian Ports Association, payable at New Delhi. EMD of the successful bidder is liable for forfeiture as per the terms of the tender document in case of any default however, EMD would be returned after award of contract on submission of Performance Bank Guarantee. EMD of unsuccessful bidder shall be returned as soon as the RFQ is finalized.

d) Performance Bank Guarantee: The successful developer/bidder will have to submit Performance Bank Guarantee equivalent to 10% of value of the project awarded within 7 calendar days from the date of Lol / LoA/ work order with validity period by the end of the date of O&M period plus 30 Days

e) The second envelope shall be superscribe with the name of work and the words "**Price Bid (Financial Bid)**" in capital letters. It shall contain full details of the price & commercial conditions. Any deviation from our standard conditions shall be specifically spelt out. Fully technical compliance bid will be eligible for opening of commercial bid.

Evaluation:

The selection of the lowest bidder will be on the basis of the total amount inclusive of all taxes & duties etc. No comparison will be made on individual item/activity basis. Price bid will be evaluated for the bidders, who qualifies in the compliance as per the specification / technical requirement specified in the document. L1 will be decided on the basis of Total price quoted by bidder for providing of implement the full material & solution successfully along with O&M for 2 years. The O&M phase can be extended by IPA with same terms & conditions by one more year.

Payment:

60% of the payment will be made against the delivery and 40% of the payment will be released against the installation and testing of user as per Government of India rules.

In the Operation & Maintenance period, the payment shall be paid under the Contract will be on quarterly basis as per Government of India rules.

Penalty:

The firm should resolve the hardware problems between 09.00 AM to 5.30 PM on all working days. The engineer will be attending the complaint and should continue in IPA office till the problem is resolved. If the problem was not resolved in 2 working days and stand-by not provided, penalty of Rs. 500 per day will be imposed subject to a maximum penalty of 25% of the quarterly payment.

Taxes and Duties:

Supplier shall be entirely responsible for all taxes, duties, license fees, etc, incurred until delivery of the Contracted Goods & services to the Purchaser. No tax or duty will be payable by the purchaser.

Applicable Law:
